With funding support from the Gala, the Kelberman Center will be able to launch an early intervention screening initiative led by a clinical licensed psychologist through the Kelberman Center Clinic. The program aims to help families with children up to 8 years of age catch early warning signs and then will assist them in accessing appropriate local supports.
